The percentage of pupils receiving the pupil premium grant is 8 % Saughall All Saints has a small number of disadvantaged children in each year group. This means that the data does not always show trends. Pupil Premium funding is spent in a variety of ways as evidenced below. Pupil Premium children are tracked individually each term and are carefully monitored as individual case studies.

To provide extra support in key subjects as required in order to maximise pupil achievement. • To support social and emotional learning. • To provide extra home/school support where there is a need to help overcome any barriers to learning that may be impacting on achievement. . To provide both curricular and extra-curricular enrichment which links to either social and emotional development or academic progress and attainment. Barriers The majority of children have low literacy skills which relates to slower progress in the children's acquisition of basic reading and writing skills Small numbers of pupils in each year group/class makes using individual funding more difficult as they cannot be collectively supported. Some pupil premium children are below typical attainment on entry to school and they are not achieving national attainment level at the end of KS1 and KS2. Emotional well- being of some children creates a barrier to them meeting their full academic ability. External barriers Attendance rates for some children who are eligible for PP funding can be low. Again with the low numbers though this is linked to a very small number of children and not enough to provide a data set.
